- No. of Beneficiaries** : Ear Examination of 5,00,000 (Five Lacs) children and surgeries – Tympanoplasty. Mastoidectomy, etc. of 100 children every year
- Justification** : It is essential to prevent deafness and blindness in 6lakh children of 826 villages. A total number of 1335 ear surgeries, 93,800 deafness treatments and 1000 hearing-aids distributed upto March 2017 after screening 34,03,241 children of Bhavnagar District from 2002 to March, 2017 and prevented them from acquiring deafness.
