**Activity** : The PNR Hospital has been functioning since 3 decades. It is a 50-bed Hospital where general and special outdoors are run. It has full-fledged ophthalmic, ENT, Orthopaedic and Dental departments where not only diagnosis and treatments are rendered but surgeries are also undertaken. Besides, the hospital has fully-equipped plastic surgery setup, arthroscopy, digital X-ray and pathology laboratory.
